Dear Bud:

Intensive creel census studies were made on Yellowstone Lake and on the Madison-Firehole drainage during the past summer. Unfortunately, there is no recent data with which to compare the Madison-Firehole study, but the Yellowstone Lake study showed an abrupt decline in the total angler success. This was to be expected with the tackle restrictions, but more important, I believe, is that we had only two letters objecting to the new rules. Of those fishermen contacted in the field, most seemed to readily accept the regulations as well as the reasons for them.

Although regulations for next season have not yet been approved, we tentatively plan to require a non-fee fishing permit, mostly to provide a contact with each fisherman and assure his knowledge of the regulations. Other basic proposals to protect native species are a parkwide three-fish limit on cutthroat and catch-and-release fishing only on grayling. Pending approval, other localized size and catch limits may be imposed, and additional waters formerly closed may be opened to fishing.

You are correct in assuming a special use permit would be required for your guided pack trips. You might let us know a few more of the details, i.e., your estimate of the size of the parties, their probable destinations and duration of stay, etc., and we will take it from there.
