Overview of the Tour

This year, the Montana Ambassador's Fly Fishing Tour will include two full days of guided fishing on the world reknowned waters of Yellowstone National Park. The clear, cold waters of Yellowstone Lake, America's largest alpine lake, are home to native cutthroat trout, the State Fish of Montana. We will cruise to the remote Southeast Arm of the lake where we will cast to 16" to 20" native trout from the shore or from small skiffs. The following day will find us in the valley of the Firehole River, where icy snowmelt is tempered by mineral rich outflows from the gevser basins to provide ideal habitat for rainbow and brown trout. some of trophy size. Here, we will share the meadows with elk, bison and other members of Yellowstone's famed wildlife community.

Each morning you will be teamed up with an ambassador host and your guide for the day. Breakfast and dinner will be served at the hotel; a picnic lunch will be served streamside. Liar's hour begins in the evening when we return to the hotel.

Evening events will be casual. A fly casting clinic will be available Wednesday afternoon for those wishing to brush up on their skills. In the

evening, Bud Lilly, one of Montana's most venerated fly fishing guides, will lead a discussion on



the waters we will be fishing. We expect Governor Stan Stephens and Park Superintendent Bob Barbee to join us for dinner. Thursday night will be reserved for tall tales. Friday evening, we'll try to bring a little order and honesty to the event with an awards ceremony after an outdoor barbecue. (In all cases your guides will be the final judges of weights and measurements.)

Jan explained that her country was revitalized by this project and she thanked the Board and the Department of Commerce for their financial contributions.

Kay Foster announced that <u>Bob Worth</u> had officially accepted the position as Custer Country vice president.

Three <u>nominations</u> were brought to the Board and passed. They were as follows: Mark Macek, Don Biscard and Con Malee. Membership report showed that there are currently 168 Ambassadors.

Amy Townsend went over with the Board the last of the <u>overdue</u> <u>Ambassador memberships</u>. Questions arose over the cut off time for when full dues should be paid by new Ambassadors. Alan Nicholson told the Board that the dues policy should be set before the next billing cycle in January.

Membership Report: Alan Nicholson told the Board that the Ambassadors have \$6081 in the bank. The Governor's helicopter bill was paid but the Board decided they needed to know in the future when they would be charged for the Governor's travel for the Catch and Release program so they can budget for it.

San Diego Trip: Dan Regan reported that approximately 50 companies have signed up for activities during the business visitation week in San Diego, October 19-23. Dan reported that a large number of Ambassadors will be going on the trip. Marilyn said she would work with Rick Jones and Amy Townsend to do a press release on the trip and also to invite a press person to travel with the group.

<u>Strategic Implementation Plan</u>: The Board decided to establish a standing committees to implement the goals of the strategic plan. The new committee structure is as follows: Membership Committee headed by Jim Hayhurst, Education headed by Randle Romney, Special Projects (tax reform, competitiveness) headed by Jim Scott, Regional Organizations (chairperson yet to be determined), and Business Recruitment and Retention. Board members will meet before the November 6 meeting in Billings to discuss if the last committee should be split into two or just that retention should be an added area of concentration.

Roles of regional ambassador vice presidents were discussed as outlined in the strategic plan. It was decided that Marilyn would send a letter out to the regional vice presidents asking them to start thinking about their goals etc. for their local Ambassador groups. Business retention was also discussed as an area that the Ambassadors need to pay attention to.

Russ Ritter discussed the possibility of the Livingston Rebuild Center closing resulting in the loss of 130 jobs due to railroad retirement costs. Marilyn will draft a letter to Washington D.C. to request support for companies like the Livingston Rebuild Center.

Terry Abelin explained that the Ambassadors should keep in close contact with the progress being made by the recently organized Rural Development Council as a vehicle to help the Ambassadors with business retention.

<u>Annual Meeting Update</u>: Marilyn suggested the meeting be held before transmittal around mid-February. Bob Henkel will have a full report for the Board in November as well as some word on the winter visitation program. Bill Martin/Big Mountain

<u>Competitiveness Council</u>: Jim Scott gave report on the three areas of concentration for the council. The areas are (1) keep conversations open between all of the economic development groups and activities that are going on, (2) promote work force training activities to keep labor involved, (3) establish a network of companies. Jim explained that the council has specifically been working to get companies/individuals together to offer assistance to the Indian Manufacturing Network. Jim introduced Ambassador Bob Vaughn and his colleague Cliff Terry who have been touring and offering their advice to Indian manufacturers. Bob and Cliff explained how they are half-way through the tour and are looking forward to going to Havre and seeing Northern Montana College. They said they would like to work on getting a manufacturing curriculum accredited at NMC so they can get some outside funding. The goal is to see how companies can help each other.


