


N estled in central Montana's Missouri River Canyon, Fly Fishers' Inn offers you comfort and convenience in a country atmosphere. At our doorstep, the premier dry fly fishing waters of the Missouri River teem with trout feeding on abundant hatches.

A flyfisher can stalk rising fish on this river, which in places is over 100 yards wide, yet offers many wadable areas. The river, whose bottom is covered with gravel and weed beds, is a gigantic limestone or spring creek.


Continuous hatches of caddis, tricos and bluewing olives provide excellent dry fly fishing along with hoppers and other terrestrials during the summer. Dry, nymph and streamer fishing in this tailwater continues into November with the run of spawning browns.

Each guest room, complete with private bath, is separate from the main lodge and has been designed for quiet and relaxation. To ensure your privacy, we accommodate a limited number of guests.

Gourmet breakfasts and dinners are scheduled so you can be on the water at the most productive times. Lunch is provided on stream.



## The Fishing



We fish from Holter Dam downstream for 35 miles to the town of Cascade. The section selected for a day's trip is determined by water conditions, hatches, and preference of the guest. Those anglers who stay a week will usually experience the entire 35 miles.

Due to the prolific insect life and consistent hatches, the best time to come can only be narrowed to between May and October. Each month has its own charm and techniques. Runoff is not usually a problem on the Missouri's tailwater fishery.

**May/June**—By mid-May the rainbows have returned from spawning in time to gorge on bluewinged olives. During June, pale evening duns, green drakes and the beginning of the caddis hatch make up the trouts' tablefare.


July/August—Caddis hatches are in full swing throughout the 4 months. Tricos will begin about mid-July and continue through August. The large number of insects on the water make the trout group up (''pods'') along current lines to suck in the insects. During times when aquatic insects are not abundant, terrestrials such as hoppers, ants and beetles are effective.

**September/October**—Fall brings the baetis hatch and some caddis. The trout know that winter is on its way, and feed heavily to survive the cold times. The nastier the weather, the more voracious the trout feed, so bring appropriate clothing. Use of streamer patterns during this period can be rewarded with larger than normal trout.

Our experienced guides will help you perfect your knowledge and skills. Although our waters challenge the pros, we can tailor your trip for the individual novice's needs.

Our facilities and amenities are available if you prefer to fish on your own or use a guide other than our staff.

For those who would like to sample other types of water, Fly Fishers' Inn guides on a number of other streams in the area. Contact us for details.





# SPRING AND SUMMER FORECAST


West central Montana has completed one of the mildest winters in recent memory. Even with an exceptionally wet spring, all indicators point to an early year. If I could forecast what outcome this would have on our hatch schedules and water conditions at the end of March, I would say to expect things to be 2-3 weeks early. I will explain why I am predicting an accelerated schedule for fishing conditions.

One factor is that snowpack is running 60-85% of normal for drainages that either directly or indirectly feed the Missouri River system including the Sun and Dearborn Rivers. There is almost no low elevation snow, most days have been 10-15 degrees above normal and this runoff that would be a preliminary to the majority of the runoff is non-existent. Another important factor is that the ice left Holter Dam completely around March 14th which is easily 3 weeks in advance of the normal time.

Coupling lower than normal flows and an early ice-off and this is going to result in water temperatures that I believe will move hatches up possibly 2 weeks or more. Even with a short water year, the Missouri River will have excellent fishing conditions throughout the season unlike the Yellowstone, Madison, Smith and Big Hole Rivers. Hopefully, spring and summer rains and snowfalls will provide all our magnificent rivers adequate flows for fisherman and fish alike.

# **AREA FISH POPULATIONS**

The Missouri River as are most fisheries in the west are in a period of transition. The drought of 1988-89 had a delayed impact on the fish population. To explain this flux in the trout population requires a little ecology lesson. I will use an analogy to simplify things. Grazing



country can support so many cattle per acre, this is called "carrying capacity". The land may be able to support 20 800 lb. yearlings or 10 1600 lb. two year olds, but not 20 1600 lb cows. The land's carrying capacity is 16,000 lbs of cattle. With normal water conditions the upper Missouri can carry over 4000 lb of trout per mile, second in the state to the Bighorn and one of the highest in the U.S.

Lets use 4000 lbs, the Missouri can have 4000 1 lb fish /mile, or 2000 2 lb. fish/mile or maybe 1000 4 lb. fish/mile, but it will not "carry" anymore than 4000 lb. of fish per mile. Low water in 1988 and 1989 resulted in poor reproduction, and the introduction of young fish into the population was weak. This resulted in more pounds of 15-20" fish in 1989 and 1990 than usual with lower competition from 7-12" fish which didn't enter the fish population. Unfortunately, the life span of trout in rivers doesn't exceed the 18-20" size or 4 or 5 years age very often. Good water in 1990 and 91 along with larger fish that were not surviving, resulted in excellent reproduction and a large number of fish that fell into the 8-14" range.

The net result was many 11-14" fish coming to the fly, fewer 15-17" fish and higher than normal percentage of 18-20" fish. I expect the coming season to have a normal number of 10-14" fish, a higher number of 14-17" fish and a smaller number of 17-20" fish than the Missouri River fisherman has been seeing in the past 4 years. The regulation that was instituted in 1990 that all browns under 22" has increased the number of 20-21" browns and made a real impact on the 15-18" browns. The Missouri has always been one of the best trophy brown trout fisheries in the U.S., and will live up to its reputation with these regulations.

The Sun and Dearborn Rivers are recovering from the low waters and 1991 was a good year on both waters for me. Hopefully the rivers will be recharged with summer rains and water temperature and cover will be sufficient that the fish will feed willingly. These two great medium sized fisheries are a real treat to fish, if you haven't met them leave room on your calendar.

# PERSONAL GEAR

We are often asked what rods, lines and clothing to bring on a trip to west-central Montana. Lets start with fishing equipment first, we recommend rods of 8"- 9 1/2" in length that will handle lines of #3-#7. My personal favorites on the Missouri and surrounding waters is a #4 weight rod to handle small dries, small to medium sized nymphs without wind and to fish small rivers and streams. For windy conditions, fishing streamers and lakes I like a 9-9 1/2 foot rod that will carry a 6 weight line. Lines for all but

lake fishing can be floating lines in either double taper or weight forward, which ever you prefer. On lakes, we recommend two intermediate sinking lines in weight forward.


In the clothing line we recommend cotton short and long sleeve shirts, cotton shorts and pants, polypropylene underwear, hat, sunglasses, windbreaker, sweaters and raingear. Wet wading from mid-July to early September is often comfortable, otherwise the angler will find chest high waders the best alternative. We recommend that you purchase leaders, flies and other small incidentals at our shop to insure you have the appropriate sizes and colors.

# FISHING REGULATIONS AND LICENSES

Fishing licenses are required by Montana and for non-residents are \$8.00 for two days and \$38.00 for the season. A \$2.00 conservation license is required once for any license. The statewide limit of 5 fish only one which may be over 18 inches is still in affect in most waters. The Missouri between Cascade and Holter Dam has a catch and release on all browns under 22 inches. The state of Montana also has a 4% bed tax on all rooms in commercial operations.

#### SIGHTS, SOUNDS AND SENSATIONS OF THE AREA

If the area around the lodge had only fishing that would be incentive enough to travel to Missouri Riverside Outfitters and Lodge. Yet, many non-fishing options can enhance the experience of visiting western Montana. We suggest a short trip to two of North Americas greatest parks, Glacier and Yellowstone Parks, which are 2 1/2 and 3 1/2 hours away respectively. Within an hour of the lodge, we highly recommend the scenic Gates of the Mountain boat ride, the C.M. Russell museum, the Nature Conservatory's Pine Butte Swamp and fossil sites. Great hiking can be found in an hour in the lower 48's largest wilderness complex, the



Bob Marshall Wilderness Area or in the Big Belt Mountains behind the lodge. Boating and swimming are readily available in Holter, Hauser and Canyon Ferry Lakes on the Missouri.

If your tastes are in shopping, golf or western history Helena, Great Falls and Butte are within easy reaching distance of the lodge. If it's open space, blue skies, moderate temperatures and the Rocky Mountains that you want the area around our lodge offers the best the West can offer.
