## OUTFITTER AND RESIDENT GUIDE REPORT BOOK

1. Make in duplicate, one copy submitted to your Fish and Game Department Regional Headquarters complete before your license will be renewed, retain one copy for your record. Sec. 26-914, paragraph 2.
2. Full name and complete mailing address of all hunters and fishermen.
3. Use additional spaces for individual big game species.
4. Young of the year either use a check or list as fawn, calf, cub, etc.
5. If client fished, check by drainage, no additional information needed.
6. True, accurate, and complete records should be submitted.

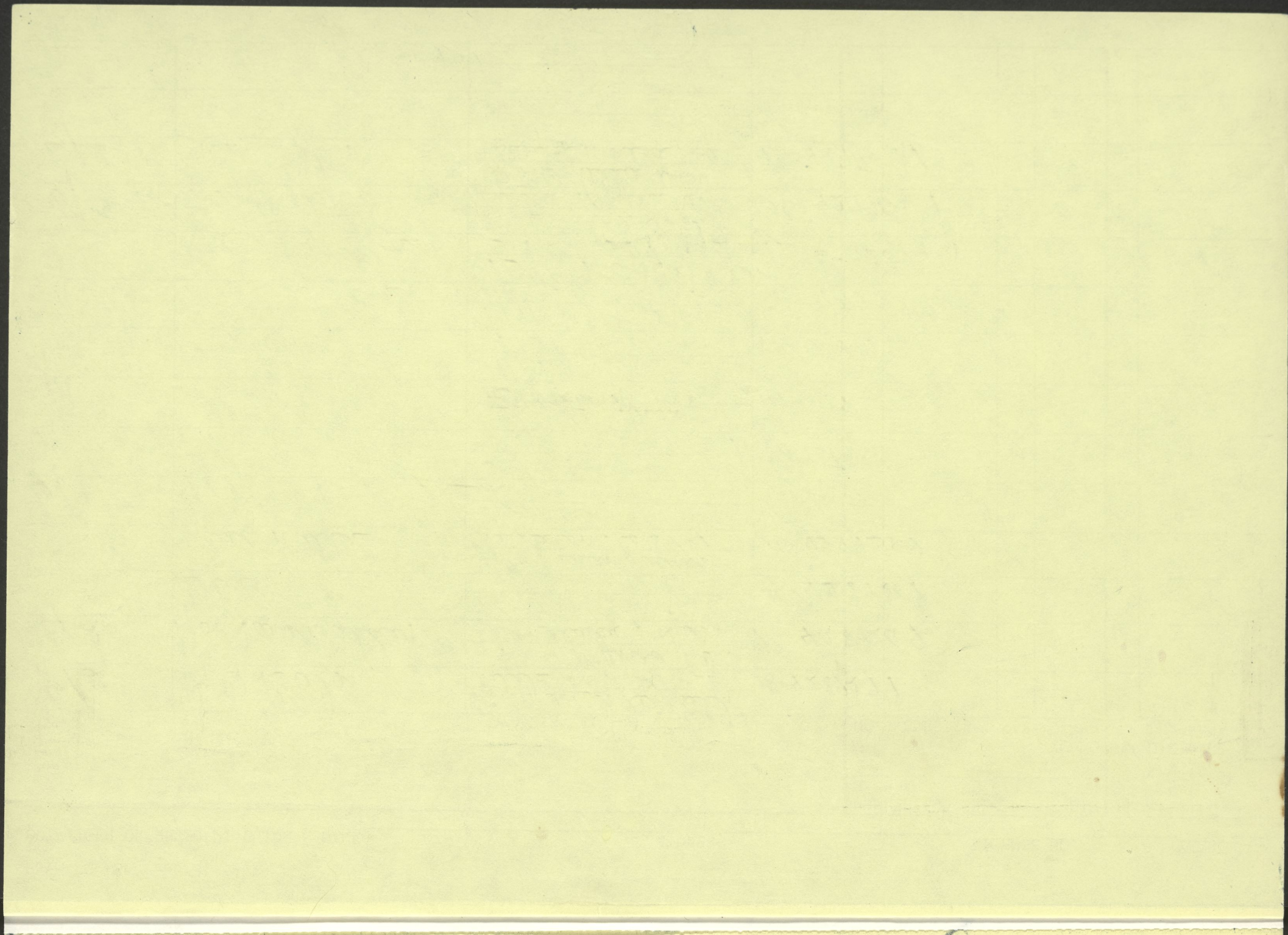
### REMINDER

Outfitters and their employees shall take every reasonable measure to provide their advertised services to their clients.

Outfitters and their employees shall not shoot, kill, or take big game animals for or in competition with those employing them while acting under employment as an outfitter.
