NEWS RELEASE: MTF GRANTS D Thompson/gnh/bud lilly

Montana Trout Foundation (MTF) president Bud Lilly announced today that the Foundation has awarded two grants to the Montana Department of Fish, Wildlife & Parks (MTFWP). The grants will enable the department to begin initial feasibility, engineering and design work for projects important for trout populations in two southwest Montana rivers.

One project will encompass replacing an aging irrigation diversion on the Shields River. This diversion was initially installed by the Lower Shields River Canal Company, and is in aged condition.. The diversion has historically acted as a barrier prohibiting the upstream migration of non-native brown and rainbow trout from reaching the Shields' headwaters, which presently support one of the region's strongest remaining Yellowstone cutthroat trout populations. The Yellowstone cutthroat was recently found to be not warranted for designation as a Threatened or Endangered species. This barrier is critical to helping maintain the population in its unhybridized state. The project will be a joint venture involving several state and federal agencies, as well as the cannel company. The Lower Shields Canal Company, Montana Trout Foundation and Fish, Wildlife, and Parks, and the Southern Crazy Mountain Watershed Association, the U.S. Fish and Wildlife Service and the Natural Resource Conservation Service are likely partners.

The second project funded by the Montana Trout Foundation involves the initial engineering design work for the potential instillation of fish screen on a specific diversion on the West Gallatin River in conjunction with the local irrigation district. The screening of the canals at or immediately below the diversion-s would ideally keep most fish (primarily trout) from moving into irrigation canal systems, where they are easy prey for predators and can lost to the fishery as the water becomes low and warm or stranded in the cannel system at the end of the irrigation season..

As an example of just how substantial that loss can be to the river's fishery; at the diversion being studied on the West Gallatin, volunteers from the Gallatin Chapter of Trout Unlimited and staff from the MTFWP have captured and returned between 600 and 900 trout 6 inches and greater in length from just below the diversion

head gates. Those numbers don't take into account the number of trout that may have moved farther down the canal and become stranded in a field or in the canal's lower reaches by the end of the irrigation season. When one compares those numbers to the MTFWP's estimate of 700 to 800 catchable trout per mile, the importance of trying ot minimze those losses becomes apparent.

Endangered Species Act is America's promise to the future By Bud Lilly

In the 1920's and 1930's, when I was growing up in Manhattan, Montana, my dad had a rule about fishing < I was not allowed to throw away a single fish. They all had to be killed and eaten. Letting fish go or just tossing them in the garbage was an unforgivable waste.

Well, I didn't waste a thing. Using mostly worms, and sucker meat for bait, I caught hundreds of big beautiful trout, and I brought them all home. The neighbors finally got so tired of me showing up on the porch with another mess of fish that they stopped answering the door.

Eventually I wised up and stopped killing so many fish. And after I opened the Trout Shop in West Yellowstone, in 1950, I learned how important those trout were to our region's economy. By the 1960's, we were urging our customers to use barbless hooks and practice catch-and-release.

Catch-and-release saved Montana's fantastic fishing. Our grandchildren will still be able to enjoy the fantastic fishing we now accept as our birthright. We've learned the hard way that it's a lot easier to protect wild things like trout while they're still abundant, rather than wait and try to restore them when they're almost gone.

That very same kind of foresight was the inspiration for the Endangered Species Act. Thanks to this far-sighted piece of legislation, bald eagles again soar across many parts of America from which they'd vanished. Restored gray whales again attract and thrill tourists on the coast of Washington and Oregon. And North America's largest bird, the California condor, is again nesting in northern California for the first time in a century.

**Endangered Species Act in Danger** 

The Endangered Species Act has rightly earned the United States the admiration of the world. Four out of five Americans favor keeping the Act vital and strong.

But there are those who would weaken or destroy the effectiveness of this momentous Act. A bill recently passed in the U.S. House of Representatives embodies the cynical impulse that the only thing that matters is short-term gain, and future generations be damned. Sponsored by Rep. Richard Pombo (R-CA), the bill would replace solid, enforceable law with weak "voluntary" protection programs.

We conservationists know from past experience that voluntarism is a wonderful thing. But it's never been enough. Our society's conservation laws will always need the power to protect the best interests of the many from the willful disregard of the few. The Endangered Species Act is our promise to future generations that we will not deprive them of the beauty and wonder we are blessed with today.

Rather than undermine the Endangered Species Act, our elected officials should reinforce our commitment to that future by fully funding the species recovery program. To do any less will not only diminish the quality of our lives, it will also betray our responsibility to our children and grandchildren.

I hope you will join me in urging Montana Senators Max Baucus and Conrad Burns to reject any attempt to weaken the Endangered Species Act. Let's not barter off the very things that matter most about Montana. Protecting Montana's wild heritage is the best investment we can make in this state's economic future. To do anything else would just be a waste.

Born in Manhattan, Montana, Bud Lilly is an internationally recognized pioneer of modern western angling. A long-time promoter of Montana business opportunities, Bud was named Montana's "Ambassador of the Year" in 1990. In recognition of his important work in fly-fishing, conservation, and business, he has received an honorary doctorate from Montana State University, the American Museum of Fly Fishing's prestigious Heritage Award for lifetime contributions to fly fishing, and numerous other awards and honors. Bud was the first president of Montana Trout Unlimited, first chairman of the International Fly-Fishing Center, and a founder of the Montana Trout Foundation. He taught science to Montana school children for twenty-five years.

Chapter Five

Names and Places

The great fisheries authorities Jordan and Evermann, in their milestone work American Food and Game Fishes (1902), commented upon a tendency we all have as naturalists when they said that "When we get hold of a fish our first desire is to know its name—What species it is." We're really that way about everything we see. We see a new flower, or tree, or geologic formation, and right off we want to know its name, and then perhaps how it happened to be there. But the name is where we start, almost all the time.

Interpreters have an added reason for wanting to know the name of everything: someone is almost certain to ask them for it later. When I worked for the National Park Service we used to joke about checking the trail along the route of our scheduled nature walk and picking all the flowers we didn't know, so that no one could embarrass us by asking us what they were.

But then, the best interpreters don't just give the name. They're ready with some lore, or some ecological connection, or some other way of giving the flower, or tree, or whatever, some meaning beyond its name. Still, I think that its name is more important to many visitors than any of the other information we might have. For many reasons, we have a compulsion about knowing what things



- Ross Bruner gave the Treasure report which was used to determine the amount of dollars that the foundation had to fund projects in 2005/06. Ross handed out a summary of financial situation. # Summary MTF APPLICATIONS FOR 2005

Title: Jacobson Spring Creek Habitat Restoration

**Applicant:** Big Blackfoot Chapter of TU (Ryen Aasheim, Project Manager)

**Purpose:** Restore a functional meander pattern and width/depth ratio to 3.2 miles of Jacobsen Spring Creek (tributary to the North Fork of the Blackfoot River) degraded by livestock. The creek now supports brown, brook, and rainbow trout; historically, bull and westslope cutthroat trout.

**Total budget:** \$300,000

**Request:** \$15,000 toward equipment costs.

Title: Cottonwood Creek Culvert Replacement

Applicant: Big Blackfoot Chapter of TU (Ryen Aasheim, Project Manager)

**Purpose:** Replace an undersized culvert on Cottonwood Creek (Blackfoot River tributary) to allow passage for bull and westslope cutthroat trout to an additional mile of stream and stop downstream erosion.

Total budget: \$87,000

Request: \$10,000 toward purchase or installation of culvert or bridge.

Title: Big Hole River Restoration

Applicant: MFWP (Peter Lamothe, Dillon Biologist)

Purpose: Develop a restoration plan for the 7 miles of Big Hole River between Rock Creek Road and

Wisdom Bridge, a reach considered critical for grayling spawning and juvenile rearing.

**Total budget:** \$16,325 to generate a plan.

Request: \$8,000 to match funds for developing the plan.

Title: Gerhart Ranch Stream and Riparian Restoration Project

Applicant: Sereta Taylor/Gladys Gerhart (George Liknes, Great Falls Biologist)

Purpose: Fencing (cattle exclusion), revegetation, and channel modifications to restore 0.75 mile of Little

Belt Creek, which supports brook, brown, and rainbow trout.

Total budget: Unknown

Request: \$3,500 to develop a design to use in applying for a Future Fisheries Improvement Grant.

Title: Chadbourne Diversion Passage Project

Applicant: MFWP (Pat Byorth, Livingston Biologist)

**Purpose:** Restore the Chadbourne Diversion on the Shields River near Clyde Park, which serves as a barrier protecting Yellowstone cutthroat trout and other native species from invasion by rainbow trout. Install a selective fish ladder that can be operated seasonally to allow passage of native species.

Total budget: Unknown

Request: \$15,000 for engineering assessments and designs.

Title: Restoration of Grayling Creek

**Applicant:** MFWP (Travis Lohrenz, Ennis Fieldworker)

Purpose: Restore habitat in the lower 2 miles of Grayling Creek to reverse the effects of riprap, an

undersized bridge, and livestock grazing on rainbow trout.

**Total budget:** \$12,422 for designing the project. **Request:** \$9,559 toward designing the project.

Title: Crooked Creek Fish Barrier

Applicant: MFWP (Ken Frazer, Billings Biologist)

**Purpose:** Replace a natural barrier in Crooked Creek (tributary to Bighorn Lake) lost in a flood event following a fire. The barrier would protect 7 miles of stream harboring Yellowstone cutthroat trout from invasion by brook, brown, and rainbow trout.

**Total budget: \$175,000** 

Request: \$15,000 for design work and development of a final engineering plan.

Title: Canyon Cattle Riparian Fencing

Applicant: MFWP (George Liknes, Great Falls Biologist)

**Purpose:** Create a cattle exclosure, provide off-stream watering, and slope and revegetate 3,050 feet of bank of the Missouri River 0.6 mile upstream from the Dearborn River Benefits rainbow and brown trout and mountain whitefish.

Total budget: \$31,815

Request: \$1,000 for seeding or erosion matting.

Title: Highline Canal Fish Screen

Applicant: MFWP (Joel Tohtz, Bozeman Biologist)

Purpose: Screen Highline Canal headgate to stop loss of rainbow and brown trout (potentially westslope

cutthroat trout) from the West Gallatin River.

Total budget: Unknown

Request: \$8,000 to assess feasibility and to design and estimate the cost of installing a fish screen.
