It is Sand Lake Press's wish to make old bird shooting titles available to a wide readership. Many such books that we plan to reprint are both rare and costly. For example, the Pringle book is usually priced at above \$2,000.00. Very few people have ever seen a copy.

We also wish to sell our books for the lowest possible price. Since we print in small press runs this proves to be difficult. We are unable to allow dealers discounts. Therefore, all books orders will need to be placed with Sand Lake Press. We hope to expand our list of titles each year. The Sand Lake Press reprints are done for the individual who wants to read these old books, rather than just collect them. In 1988 the following reprints are available:

1. Twenty Years' Snipe Shooting by J.J. Pringle. First published in 1899 this title is among the rarest of North American bird shooting books. Pringle was a planter in Louisiana who kept careful records of his shooting between 1867-1887. He used English shooting methods and guns made by Joseph Lang, Steven Grant, and James Purdey. This is an interesting book, and one that the historian will appreciate. Price: \$14.95 hardbound.

2. Krider's Sporting Anecdotes by Milnor H. Klapp and John Krider. First published in 1853. This book should be noted as one of the first important North American bird shooting titles. It is a good early work. Excellent chapters on snipe, sora rail, and canvashack. Price \$14.95 hardbound. (available September 15, 1988)

3. Upland Birds And Waterfowl With Ray P. Holland. This collection is taken from two of Holland's books, with chapters dating in the 1915-1940 era. Ray P. Holland was editor of *FIELD & STREAM* for nearly 20 years, and was one of the best writers of his time on bird hunting subjects. If one enjoys bird hunting, and hasn't read Holland, this book is highly suggested. Holland was a standout. Price \$18.95 hardbound. (available September 15, 1988)

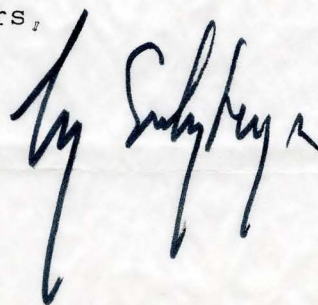

Dear Datus,

Thank you so much for your letter. I was delighted to hear from you although I am surprised that you are now living in Montana. John Moore had told me that you were liason man from the State department with the Coast Guards. I don't believe there are many Coast Guard stations in Montana. Therefore I assume that you have resigned and gone into a new field. Is this correct ?

I have fished in Montana on the middle fork of the Flathead river on the Kootenai river that flows toward Canada, and in other streams here and there which I cannot quite remember. My recollection is that the fishing was excellent. I had some pleasant battles with Dolly Vardens in the Flathead. They are strong and vigorous although not very good to eat.

I appreciate your offer to help me find a good spot in Ireland but I discovered this summer that I am not in a position to fish trout. I can't see a fly on the water and I have a very hard attaching it to a leader. On the whole I have been incapacitated until my eyes are cured. And for the present there is no imminent indication of that probability.

I have a great friend who lives in Montana. He is a vigorous old man (who is in his 80's) whom I knew when he was a colonel in an armored combat team in Italy opposite Cassino during the war. His name is Henry Gardiner and his address is P.O. Box 1951, Bozeman, Montana 59715. Be sure and mention me if you write to him. I haven't heard from him for some months now and I hope he is still alive and well. But one cannot guaranty

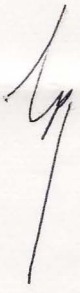
