

RULES FOR DAY RODS : 1986 SEASON

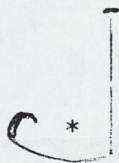
- 1 The season opens on Thursday, 1st May and lasts until Wednesday, 15th October 1986.
- 2 If rods are unable to take up their fishing a minimum of three days' notice will be required, otherwise a charge will be made. Cancellations should be made to the Fishing Secretary, at the Estate Office.
- 3 No fish under 12" overall may be kept unless diseased, damaged, or in irrevocably bad condition. All fish over that size must be kept. All grayling and coarse fish, of whatever size, must be killed and taken away from the river.
- 4 The day's bag is limited to five fish per beat. The bag for two rods [one of whom must use a guest ticket] fishing on one beat is limited to eight fish per day. It is particularly asked that fishermen shall not purposely catch fish and replace them.
- 5 The charge for two rods fishing one beat is £70.00. The charge for a guest sharing a rod where the limit is five fish is £52.50.
- 6 Rods are requested to fill in their return cards and send them to Mr K Debenham by the Sunday of the week to which they refer. THIS IS IMPORTANT.
- 7 Upstream dry fly fishing only. Maximum size of hook permitted, size 10.
- 8 Upstream nymph fishing will be allowed to those who wish to try this method from August 1st onwards, when the fish ignore the dry fly.
- 9 Maps are available at Leckford Abbas; Longstock House; 26 Longstock [Mr Kim Debenham's residence]; North Lodge, Longstock Park [Mr D Fake's residence]; and the Estate Office. Please be sure you know which are your beats.
- 10 Will newcomers please be certain that they bring the necessary gear as it is impossible for the Keeping Staff to supply it.
- 11 If an appointment is made with a member of the Keeping Staff will you please be punctilious in keeping it or, if you are unable to do so, please cancel the appointment as far in advance as possible.
- 12 If you have any complaint about the fishing, the accommodation, or anything appertaining to your visit to Leckford, would you be good enough to come to see me, or write to me, and not deal with the individual concerned. I will look into the matter on your behalf.
- 13 Tipping is not allowed but contributions to the Keeper's Christmas Fund will be greatly appreciated at the end of the season. These should be sent to me at the Estate Office.

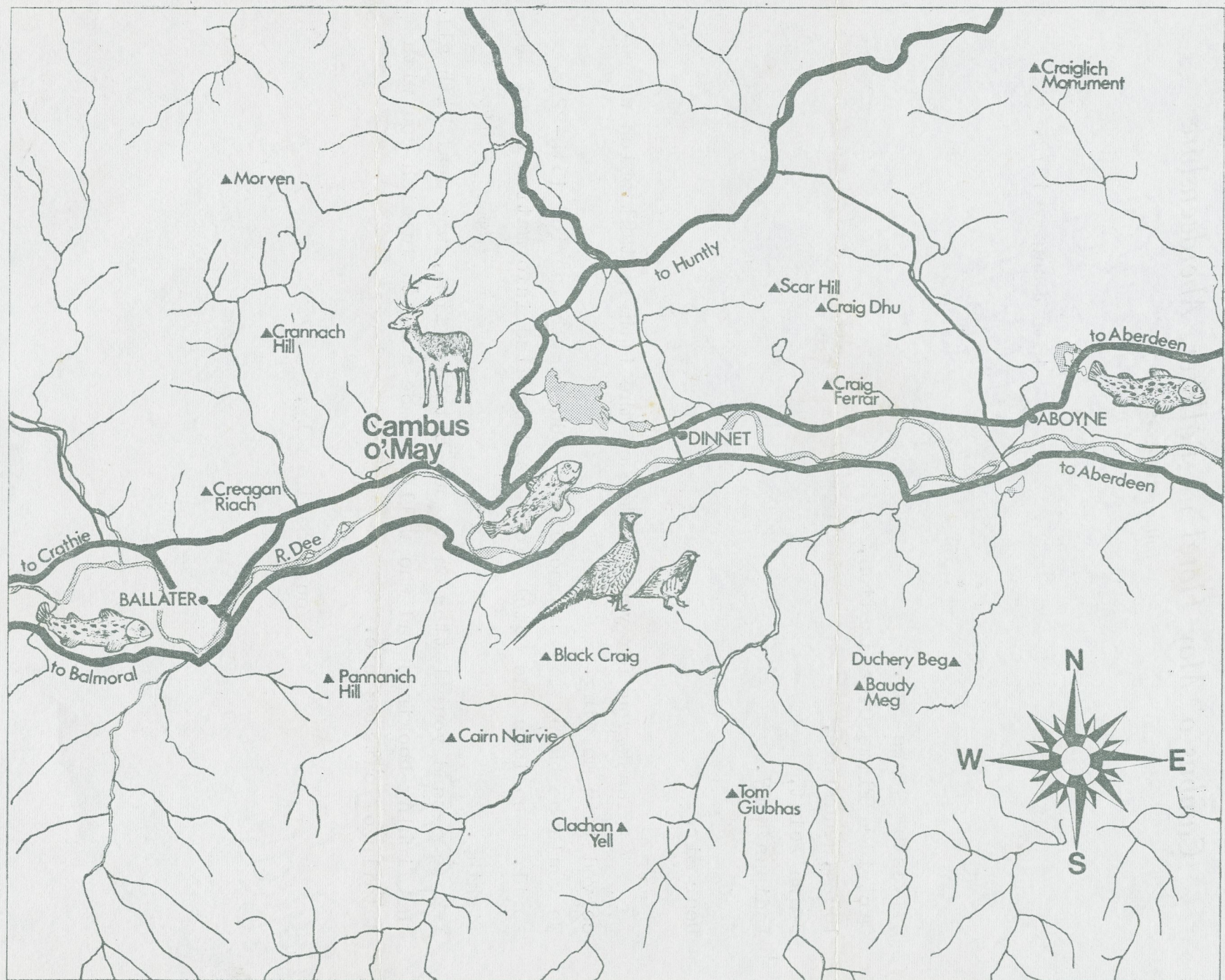
Thank you for your letter of the 11th instant which we received this morning.

RIVER TWEED, CORNHILL, NORTHUMBERLAND.

1981 Season.

SITUATION

In the beautiful Border countryside some 60 miles from Newcastle-upon-Tyne, 50 miles from Edinburgh and 14 miles from Berwick, on the east bank of River Tweed between the village of Cornhill and the town of Coldstream. The fishing is easily approached from the public road but is entirely secluded in an attractive woodland setting.

PARTICULARS

Originally known as Cornhill No.1 Beat the fishing extends to approximately 1 mile on the English or right hand bank of the Tweed and runs from the mouth of the Dedda Burn to Coldstream Bridge. There are five named salmon pools and other areas which hold fish. Salmon, sea trout and brown trout are taken.

Whereas these particulars are believed to be correct. They are not so guaranteed and shall not form the basis of any offer or contract.

SEASONS

The salmon fishing season commences on 1st February and the first fourteen days are restricted to 'fly only'. From February 15th to 14th September bait fishing is also permitted but from 15th September to 30th November there is again a 'fly only' restriction. In general the seasons and fishing rules for the river are prescribed by the Tweed Commissioners and all tenants will be required to obey the edicts of the Commissioners and to indemnify the owners in the event of their so failing. In any event fishing is permitted only by approved sporting methods.

Until the advent of U.D.N., the Tweed fished particularly well in the months of February, March, April and part of May, and there was a smaller but still good run of large fish in the last three months of the season. In more recent years the Spring fishing has not been so good and the majority of the fish have been taken in the Autumn when there now appears to be an enhanced run. In recent years the average bag has been about 40 but over 80 salmon were caught in the 1975 season.

ACCESS

Access to the Beat is obtained from a private road immediately adjacent to Coldstream Bridge and there is also a pedestrian way from the public road over the fields to the south.

LUNCHEON HUT AND BOATS

A luncheon hut is sited close to the river bank in the upper half of the Beat. There are two rowing boats on the length - one is normally kept at the Monument Pool and the other in the upstream reaches. Unless special prior arrangements are made with the Agents the boats may be used only under the supervision of the ghilly.

GHILLIES

A ghilly is normally available between 15th February and 30th April and between 15th September and 30th November. On request it may be possible to make arrangements for a ghilly at other times in the season. Tenants are normally expected to present the ghilly with a gratuity at the end of the let.

FISH RECORDS

All fish taken are the property of the tenant but each fish must be recorded as to weight, lure, pool and the date caught, and these records are to be handed either to the ghilly or forwarded to the Agents.

LETTINGS

Are for one or two rods and the rentals per week for the 1981 season

are as follows:

Rentals will be paid to the Agents in advance and not less than one half of the rental will be paid at the time of reservation, the balance being due ten days prior to the commencement of the let.

The following Rules and Conditions must be read and understood before commencement of fishing.

No 786

The ticket-holder is entitled to angle with rod and line during six days a week (Mondays to Saturdays inclusive) on both banks of the River Spey from the road bridge across the River at Broomhill, near Nethybridge, down to and including the Long Pool situated at about one mile below the Old Spey Bridge, a distance in all of seven miles or thereby and on the River Dulnain on both banks from the bridge at Inverlaidnan to the mouth, a distance of approximately twelve miles.

N.B.—Ticket-holders are respectfully requested not to fish beyond the bounds of the Association water, at both ends of which Notice Boards have been erected.

Anglers are requested not to leave litter on the banks and are reminded that it is by law a punishable offence.

11th FEBRUARY to 30th SEPTEMBER

CONDITIONS TO BE OBSERVED BY HOLDER OF FISHING TICKET

1. The ticket will be available only to the person in whose favour it is granted, and is not transferable.

2. NO SUNDAY FISHING.

3. The holder of the ticket shall have the privilege of angling with a single rod and line on the days, within the hours, and at places specified hereon, and that during the period mentioned hereon, but the holder must not take or kill any salmon fry or other fry or any unclean fish or any fish under 8 inches in length, and all such fish if taken shall be returned immediately to the water. In order that the Association records may be correct, the holder of the ticket is required to make a return to the Secretary of the number and weight of each Salmon, Grilse and Sea Trout caught by him and that within 24 hours of each catch, also lure used, whether fly, worm or minnow.

4. The holder of the ticket must exhibit it at all times when asked to do so to the Association's Watchers, the Watchers of the Proprietors or the Watchers of the Spey Fishery Board, or other persons having authority to demand exhibition thereof, and any person refusing or failing to exhibit his ticket may be turned off the river by such person or persons.

5. The holder of the ticket shall give all the assistance in his power to prevent illegal fishing and poaching, and he must allow the Watchers or other persons duly authorised to inspect the fish and tackle in his possession.

6. Care must be taken of the fences, woods, and other property on the land adjoining the river or its tributaries, and any ticket-holder found injuring these shall be liable for the damage done by him, besides incurring the forfeiture of his ticket.

7. No ticket-holder shall be accompanied by a dog, nor shall he in any way interfere with the game on adjoining lands.

8. No fish taken in the Angling Association's water may be sold.

9. The use of a gaff is forbidden between the 11th February and 1st April.

10. Holders of trout tickets must not use a rod exceeding 10 feet in length, the permitted lures being fly or worm only.

11. Trout anglers fishing in a pool must give way to those holding a salmon permit.

12. No angler shall cut in front of another when fishing a pool, but each angler shall take his turn of fishing in order of his arrival at the pool, and must move at least one yard after every cast.

13. No prawn or shrimp fishing at any time. Any other type of lure will be allowed when the river is above Normal Summer Level on the marker at the New Bridge. Only fly fishing is allowed (not maggot or fly and maggot) when the water is below Normal Summer Level (Red), but excluding pools 1, 2, 3, 4 and from the tail end of the Tarrig Mor Pool (No. 12), Craggan Sands (No. 13) and down to the Inverallan Burn on plan of Association Water, where any type of bait or lure, other than prawn or shrimp, can be used.

14. The first three Salmon caught each season must be certified as "clean" by at least two Members of the Committee.

15. Any ticket-holder infringing any of the foregoing Rules and Regulations or who may be convicted of illegal fishing or any offence under the Acts relative to salmon or trout fishing shall forfeit his ticket with all privileges carried by it. Such forfeiture shall be sufficiently instructed by a letter under the hand of the Secretary of the Association directed to the ticket-holder at the address stated on his ticket.

16. No float fishing between the hours of 10 p.m. and 5 a.m.

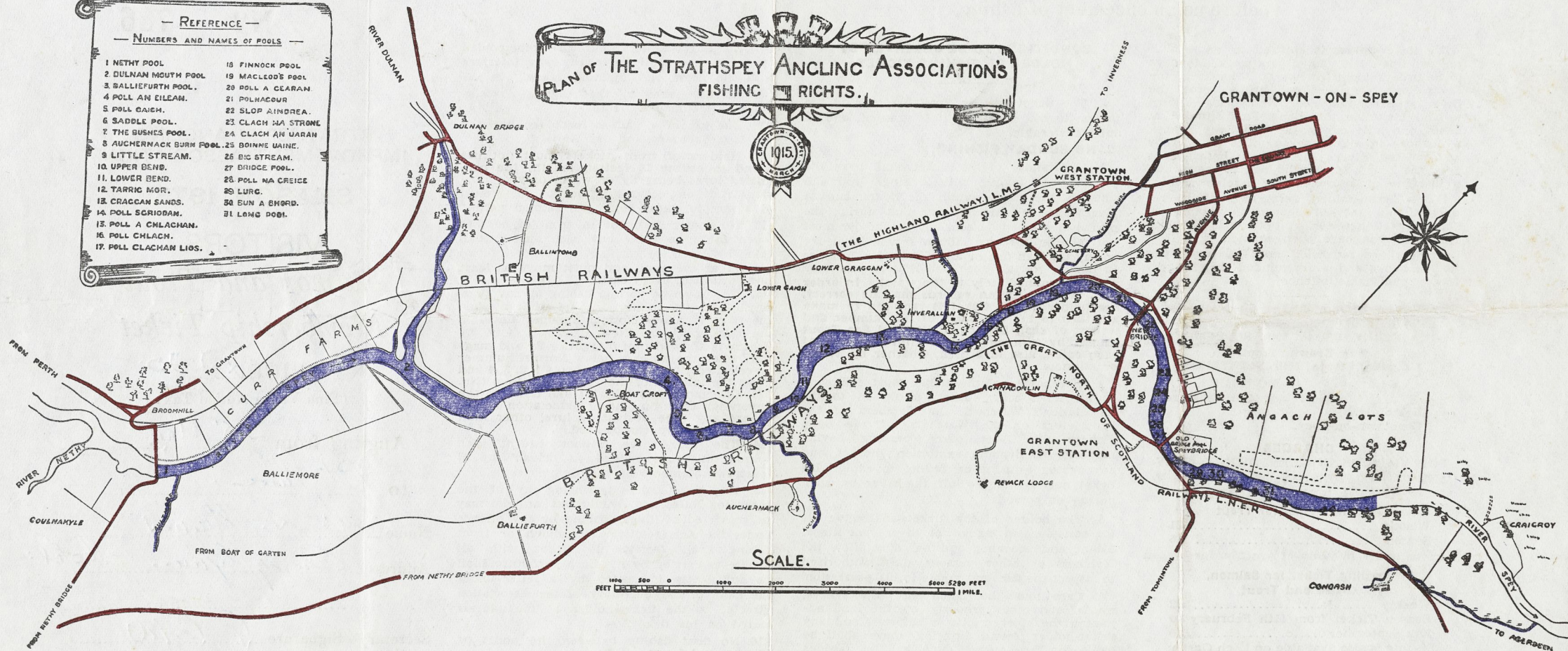
