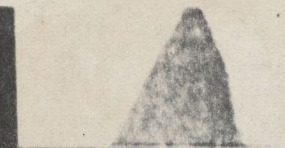

## DR. WYNEKOOP IS FOUND GUILTY

### Given 25-Year Sentence For Slaying Her Daughter-In-Law

CHICAGO, March 7. (AP) — Only a higher court or death itself can save Dr. Alice Wynkoop from the penitentiary now.

A jury convicted her last night of slaying her daughter-in-law, Rheta, in the "operating table" murder that horrified the nation. It fixed her sentence at 25 years' imprisonment in the penitentiary. Only two ballots were taken.

The murder drama that began when Rheta's body was found, a bullet in the back, on Dr. Wynkoop's operating table last November 21, kept its interest in rushing crescendo to the last.

With the jury in the place, ready to accept the verdict, Judge Harry J. Miller pronounced the full physical and mental condition of the 40-year-old woman, who was a legitimate doctor, but the specter of the verdict strike her dead. She did not need his ministrations. She heard the verdict as she sat in her wheel chair without sign of a quiver. She turned to two of her children, Walker and Dr. Catherine Wynkoop, and said:

"The home, now children, and sleep. Your mother is not guilty. No, no. Not guilty."

In a moment it was over and Dr. Wynkoop was being wheeled from the courtroom back to the infirmary out at the county jail. There she will await the result of her attorney's efforts to win a new trial.

Arguments for a new trial have been set for March 24. If they are denied, an appeal to the state supreme court is planned.

When the verdict was read by Foreman Fred Orin, oldest member of the jury, there was murmur of approval from some of the spectators.

Dr. Wynkoop stared straight ahead. A moment later she was wheeled away to an anteroom where Dr. Catherine and Walker shaded her hands and whispered to her, but it was the mother and not the children who did the comforting—driving to reassure them that it was not she who chloroformed and shot Rheta.

Walker Wynkoop called the verdict a "gray day," adding that he was getting a \$5,000 loan on some property to finance an appeal. Dr. Catherine, 36, was "an outcast," Walker said. "I am of Indianapolis, former of Indiana State, apparently was never married."

## Roosevelt Wants To Have Congress Adjourn In May

WASHINGTON, March 7. (AP) — President Roosevelt is understood to be ready to bring about adjournment of the 72d Congress at the earliest possible moment and by mid-May at the latest.

Only one more message will be sent to capital hill, that one relating to war debts negotiations. It is described in usually reliable quarters as more in the nature of a report than a proposal for new legislation.

There is every indication that the President is willing to sacrifice some "pet" measures now before Congress in the hope of pressing the existing program to conclusion.

Congressional attention, it is indicated, will be focused henceforth on passage of the necessary appropriation bills to keep the government in funds next year; the long-haul plugging income and general tax measures and the proposed tariff bill upon which House hearings open tomorrow.

## THREE BANDITS ROB CALIFORNIA BANK

### Bind Four Employees And Escape With \$8,000 In Currency

SUISUN, Solano County, Cal., March 7. (AP) — Two masked robbers, threatening death with a sub-machine gun, held up and bound four employees of the Suisun bank today and escaped with \$8,000. A third robber drove an automobile in which the men escaped.

Apparently concealing themselves in the bank building, two men suddenly confronted the janitor, Al McGeorge, as he arrived at 5:30 a. m. He was bound and then the robbers waited for the bank officials to arrive.

The men carried a sub-machine gun, McGeorge said, and threatened to kill Charles E. Turp, assistant cashier, who arrived at 7:45 a. m. unless he opened both vaults in the bank.

Turp opened one vault but told the robbers the other had a time lock which he could not open. They threatened to kill him, he said, but he finally convinced them by his telling the truth. In the time locked vault was \$10,000.

The robbers apparently knew the bank officials, Turp said.

Using wire, the bank bound Turp and then tied up George Wilson, teller, and John Elbert, assistant cashier, when they came into the building. The robbers kept the bank and the bank closed and a number of

## U. S. JOINS IN HUNT FOR JOHN DILLINGER

### Federal Agents To Assist Police In Searching For Desperado

CHICAGO, March 7. (AP) — The federal government joined today in the hunt for elusive John Dillinger, escaped desperado.

Dillinger, "seen" in a hundred different places, but found nowhere, has been on the loose five days now and is the object of one of the greatest manhunts in recent years.

Two attaches at the Crown Point, Ind., jail from which Dillinger made his "movie" escape, were taken into custody late yesterday, charged with aiding and abetting.

One was released later on his own recognizance by Judge William Murray.

He is Deputy Sheriff Ernest Blunk, fingerprint master of the jail, at whom Judge Murray said:

"I'm satisfied there was nothing at all in Blunk's performance. He didn't have any nerve — that's all that was wrong with him."

Turnkey Sam Calton, 44, is the other jail guard under arrest.

The federal government entered the case because Dillinger violated the Dyer act in transporting a stolen automobile from Indiana to Illinois after his jail escape.

Authorities were guarding Cook county's banks against a possible raid by the bandit leader and fugitive members of his gang.

Governor Paul McHugh had before him a report of the management of the Crown Point jail. He said he could not remove Sheriff Blunk, pointing out that the power was vested in the county's circuit court.

The head of the Lake county commission called on Sheriff Blunk to resign "for the good of the Democratic party," but the woman sheriff promptly refused.

# THREE DILLINGER BANDITS AND WOMAN CONFEDERATE ARE SENT EAST BY TRAIN

## Plane Speeds Leader Of Outlaws Across Texas Towards Indiana

LITTLE ROCK, Ark., Jan. 30.—(AP)—A squad of detectives and uniformed policemen armed with submachine guns and shotguns was on guard at the municipal airport here today when an American Airways plane returning John Dillinger, midwestern desperado, in custody of officers, to face murder charges, arrived at 12:25 p. m.

FORT WORTH, Tex., Jan. 30.—(AP)—John Dillinger, midwestern gang leader, arrived here by airplane from Tucson, Ariz., at 8:44 a. m. today in custody of four officers who are returning him to Indiana to face murder charges.

The group left on the regular passenger plane for Memphis at 9:15 o'clock with stops scheduled at Dallas, Texarkana and Little Rock.

There were six other passengers, including two women, on the plane that brought Dillinger and his guards to Fort Worth.

It was met by a delegation of heavily armed policemen.

Dillinger was without coat or hat as he stepped from the plane into the cold air. An officer threw a coat around his shoulders. He was handcuffed.

An officer walked in front of him and one walked behind. Policemen armed with machine guns walked beside the group to the airways administration building. A machine gun was pointed on the second floor and was aimed on the field.

The outlaw was taken to the office of John K. Lyles, traffic manager, on the second floor where breakfast was ordered from a nearby restaurant.

The plane arrived in Dallas at 9:40 a. m. and took off two minutes later for Memphis.

## Hundreds Gather At Depot As Gangsters Leave For Indiana

With scores of officers surrounding the Southern Pacific station, many of whom were armed with machine guns, and while 1,500 persons quietly witnessed the proceedings, four members of the notorious and widely-feared John Dillinger bank robbery gang, imprisoned here since Thursday night, boarded a special car this morning in the custody of Indiana authorities and promptly at 10:58 o'clock began the journey to the state which demands that they answer for their crimes.

The gangsters—snarling, glaring Harry Pierpont, the "trigger man," sullen Russell Clark, and suave Charles Makley—together with smiling Mary Kinder were placed in the custody of Capt. Matt Leach of the Indiana state police and a number of other officers who made the trip here with him to gain extradition.

The men are wanted in Lima, O., in connection with the slaying of Sheriff Jess Barker there last October, while Mary Kinder must face charges of aiding and abetting escaped convicts. The charge against her carries a term of from two to 16 years.

### Proceedings are Brief

The extradition proceedings in superior court this morning before Judge Fred W. Pickett consumed not over ten minutes and terminated the bitter controversy, which began Sunday, as to which state would be given the custody of the crime ring members. Indiana emerged victorious as to the four men, including Dillinger, who was spirited away by plane yesterday afternoon, and the Kinder woman. The Indiana authorities also came here as the authorized agents for Ohio.

## DILLINGER STAGES FISTIC SCUFFLE

Swings On Deputy Farrar As He Is Led From Cell For Trip To East

Shouting he was being "shanghaied," usually suave, soft-spoken John Dillinger turned into a wild man yesterday in the Pima county jail as an attempt was made to manacle him preparatory to his removal to the Tucson airport where, a few minutes later, he was to begin a surprise journey to East Chicago, Ind.

Coatless, wild-eyed, the gang chief-tain kicked and scratched, all the while uttering curses, as Undersheriff Jake Farrar tried to force his arms into a pair of handcuffs. Blood began to fly as the gunmen's fingernails ripped into Farrar's hands and arms.

"You're shanghaiing me," Dillinger shouted, "and I won't forget it. I'll come back here and get the whole damn bunch of you."

Fear-stricken, Harry "Trigger Man" Pierpont, Russell Clark and Charles Makley, watched the battle from nearby cells, uncertain of what was about to take place.

"They are going to put you on the spot," Pierpont shouted worriedly.

But Dillinger, Farrar said, knew he was not being put "on the spot," at least for the time being.

"Guess I'm going to East Chicago, eh?" he asked the undersheriffs.

**Shackled by Officers**

Securely shackled and with Farrar holding him, Dillinger was marched out of the jail at 4:45 o'clock. Guards preceded and followed him as he was hurried down the stairs to the back door of the sheriff's office where Sheriff John Belton's car was waiting, its motor running.

So sudden was the removal of Dillinger that more than 100 curious persons loitering about did not know what was actually happening.

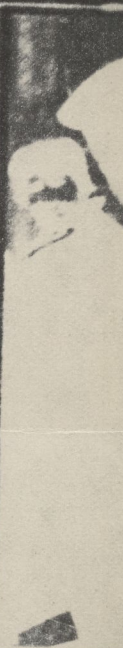

"Just the same, though, we'll have a few extra guards in the jail while he is there and they'll be on the job with machine guns, too."

The sheriff said the military unit for Dillinger would be constantly under the eye of an armed guard patrolling the iron-barred hall leading to it.

## COPPER MINING CHIEFS DISCUSS CODE REVISION

### Seek Changes In Proposed Agreement With NRA

WASHINGTON, April 4. (AP)—Leaders of the copper mining industry conferred today with NRA officials on final revisions of their code, expressing belief that it would be completed within a few days.

# DILLINGER JURY HEARS STORY OF SHERIF HOLLEY

## Indiana Politics in Turmoil Over Parole Charge.

While Indiana Democrats and Republicans wrangled heatedly yesterday over the political implications of the John Dillinger jail break, the special grand jury at Crown Point proceeded leisurely with its investigation of the outlaw's escape.

Sheriff Lillian Holley spent most of the day before the six jurors and was reported to have been questioned at length concerning the jail management and rules. She could offer no information about the actual escape, having been home when Dillinger bluffed his way out of her prison with a wooden pistol.

### Cahoon Also Testifies.

The only other witness of the day was Sam Cahoon, 64 years old, the jail handy man and turnkey, who was the first to open a door for Dillinger and who has already been charged with abetting the desperado's escape. Cahoon was said to have declared that he believed the pistol in Dillinger's hand was a real one and that he acted in fear of his life.

Nearly thirty other witnesses remain to be questioned by the jury, including Ernest Blunk, the jail fingerprint expert, who has also been accused of helping Dillinger to freedom. The grand jury appeared in no hurry to complete its inquiry.

### Blunk Taken to Capital.

At a late hour last night Blunk was taken from Lake county on a mysterious mission to Indianapolis. Four state policemen accompanied him. It is known that Blunk went to Indianapolis to talk with Attorney General Philip Lutz Jr. Mr. Lutz early today confirmed this. The attorney general will not see Blunk until this forenoon, however. He refused to explain the purpose of Blunk's mission.

After two apparent plots to free the three had been nipped, General Bush assailed corruption in Lima politics and strengthened his guard.

Lacking any special training in the duties of a sheriff, the late Dr. Roy F. Holley bravely but foolishly walked into the home of a Ross madman and was slain.

Lacking any special training in the duties of a sheriff, his widow, Mrs. Lillian F. Holley was appointed to succeed him and it fell to her lot to guard the nation's foremost desperado. The elaborate system she set up to guard her prisoner crumpled completely after 32 days and John Dillinger walked out of the Lake county jail.

### Court Rules Chains to Remain on Gunman In Lima Trial

Court House, Lima, O., March 8.—Deputy Sheriff Wilbur Sharp, a small sober officer, today looked directly at Harry Pierpont and said: "That's the man who shot Sheriff Sarber."

Deputy Sharp was the third man to testify in the trial of the former henchman of John Dillinger for the first degree murder of Sheriff Jesse L. Sarber last October in a jail raid here in which Dillinger was liberated.

In an almost inaudible voice, Sharp told of the exciting events, which accompanied the murder of the sheriff. Sharp was sitting in the jail office with the sheriff and Mrs. Sarber when the man he identified today as Pierpont came in with two other men.

"One of the men said: 'We're officers from Michigan City and we want to see John Dillinger,'" the deputy testified.

# Wooden Guns Fooled British in Days of Revolutionary War

Chicago, March 8.—Possibly "Whittling John" Dillinger, elusive desperado of the central west, is a historian.

Perhaps he knew, from reading history, just how efficacious wooden armament can be, for its use is an ancient camouflage that has fooled some of the world's wisest people.

Maybe he remembered, when he walked out of the "escape-proof jail" in Crown Point, Ind., the other day after bluffing guards with a wooden pistol, that the American continent is tricked the British during the revolution with a brave display of pig cannon.

History is full of such incidents. In the world war camouflage artists spent lots of time rigging up various harmless but formidable looking objects so the opposing armies could fool one another.

And in this modern day a Chicago financial institution, capitalizing on the well known psychological effects of camouflage, has placed a life-sized wooden soldier, which shoulders a toy rifle, on guard to supplement its forces of special police.

"A secret agreement and co-operation for fraudulent and deceitful purposes between two or more persons; the playing into each others hands."

"That's a good definition of exactly what I mean," Barce commented.

Prosecuting Attorney Robert G. Estill, who emerged from the jailbreak investigation room at noon with Barce, declined comment except to state that "whatever Mr. Barce says, I stand behind."

Martin J. Smith, Crown Point attorney and former republican criminal court judge, who has joined the probe as a representative of East Chicago police, was with Barce and Estill. Smith, however, declined to make a statement.

The republican warden of the jail soon is to be dismissed by Sheriff Lillian Holley, a democratic standard-bearer, or will resign suddenly, according to widespread reports today.

Perhaps he knew, from reading history, just how efficacious wooden armament can be, for its use is an ancient camouflage that has fooled some of the world's wisest people.

Maybe he remembered, when he walked out of the "escape-proof jail" in Crown Point, Ind., the other day after bluffing guards with a wooden pistol, that the American continent is tricked the British during the revolution with a brave display of log cannon.

History is full of such incidents. In the world war camouflage artists spent lots of time rigging up various harmless but formidable looking objects so the opposing armies could fool one another.

And in this modern day a Chicago financial institution, capitalizing on the well known psychological effects of camouflage, has placed a life-sized wooden soldier, which shoulders a toy rifle, on guard to supplement its forces of special police.

## REPORT DILLINGER SEEN IN NEW JERSEY

### Eastern Police on Look-out for Bandit

New York, March 8.—A radio police alert ordering New York and New Jersey authorities to be on the lookout for an automobile containing two men, "one of whom may be John Dillinger," was broadcast early today.

The alarm was sent out after a filling station operator at Woodbridge, N. J., thought he recognized Dillinger when the car stopped at his place for gasoline.

It was the third time in less than 24 hours that the escaped desperado had been reported somewhere in the vicinity of New York.

The automobile bore New Jersey license plates, the filling station operator said, but he was unable to remember the numbers.

political connections to work with him in the investigation.

Murray discarded the suggestion, contending such a move would not be in the public's interest since the appointee, being named by Estill, would work with him rather than independently. The two argued vigorously for a few more minutes before Judge Murray resumed the trial then in progress.

"Plenty of evidence of collusion" between John Dillinger and one or more of his guards in the Lake county jail in Crown Point, from which he made his fantastic "wooden gun" getaway five days ago, was announced by Deputy Attorney-General Edward Barce today at the same time a move to oust the warden, Lew Baker, sole republican holdover in the institution, was reported underway.

Asked if evidence of collusion had been obtained in the joint state and county probe of Dillinger's jailbreak, Barce replied:

"Not only definite, but very definite evidence of collusion between Dillinger and some person or persons in the jail has been obtained."

"Plenty of That, Too"

Asked if he meant criminal negligence instead of collusion in his assertion, Barce answered:

"No, I'm not talking about negligence, although we've found plenty of that, too."

Barce was shown a dictionary definition of the word "collusion." The definition is:

"A secret agreement and co-operation for fraudulent and deceitful purposes between two or more persons; the playing into each others hands."

"That's a good definition of exactly what I mean," Barce commented.

Prosecuting Attorney Robert G. Estill, who emerged from the jailbreak investigation room at noon with Barce, declined comment except to state that "whatever Mr. Barce says, I stand behind."

Martin J. Smith, Crown Point attorney and former republican criminal court judge, who has joined the probe as a representative of East Chicago police, was with Barce and Estill. Smith, however, declined to make a statement.

The republican warden of the jail soon is to be dismissed by Sheriff Lillian Holley, a democratic standard-bearer, or will resign suddenly, according to widespread reports today.

Mrs. Holley said "maybe the reports are true," but otherwise declined to comment on the rumors.

Despite the sheriff's reticence, county political observers claimed

investigators were unidentified plainclothesmen assigned to the county by Philip Lutz, Jr., attorney-general.

#### Represents Police

The fifth is Martin J. Smith. Smith said he has been appointed an investigator for the state at the request of the East Chicago lodge, Fraternal Order of Police, to which the late Policeman W. P. O'Malley, holdup victim of the wary Dillinger, belonged.

Capt. Timothy O'Neil, president of the police lodge, went to Indianapolis yesterday to get Smith appointed by Lutz to represent the lodge.

"Members of the F. O. P. in East Chicago are bitter over the death of O'Malley and unwilling to let Dillinger's escape pass without a thorough investigation," O'Neil said.

"While we believe his getaway was due to laxity and carelessness, we don't believe the blame should be put on a man because he took a drink a couple of years ago," he added.

O'Neil said he referred to Sam Cahoon, jail handy man, now under arrest in the county jail on a charge of aiding Dillinger to escape. Cahoon served a 40-day sentence for intoxication in 1928 when he was unable to pay the \$40 minimum fine for drunkenness under the former Indiana "bone dry" law. He later was retained as a jail employee by the former republican sheriff, Ben Strong of Hammond, and worked at the jail thereafter until he was suspended by Sheriff Holley pending his trial on the Dillinger charge.

#### A Republican Angle

Smith said he had no statement to make today regarding his part in the probe. He said his power is limited.

Sheriff Holley said "O, so that's it" when informed of Smith being appointed by Lutz.

Political observers said they detected a familiar odor in the Smith appointment. They recalled that Smith not only is a former republican officeholder, but that the East Chicago city administration is republican and that therefore the police department in the Twin City has G. O. P. affiliations.

These same observers interpreted O'Neil's comments to mean the Twin City police do not approve of the Cahoon arrest, engineered by Estill and Barce, and that some more sizable game would be more acceptable.

"I don't believe the East Chicago police have anything to cry about," Mrs. Holley asserted. "I can't forget that Dillinger gave them the runaround when he carried away \$20,000 from the First National bank, after killing Policeman O'Malley."

Mrs. Holley also took a poke at Warden Louis Kunkel of the Michigan City prison during her combative mood this morning

when they learned that Matt Brown, one of the deputy sheriff guards taken captive by Dillinger before he got out of the jail, is more than 80 years of age.

Paul K. Shephard, a deputy attorney-general, was sent to Fort Wayne to check the appearance there of parents of Harry Pierpont, Dillinger gangster, with their Indianapolis attorney, M. V. Fogarty, on Saturday, before the break. Lutz said he was informed the Pierponts left Fort Wayne at 4 a. m. Saturday and arrived in Crown Point before Dillinger fled.

#### Arrived After Break

Estill said, however, that his information is that Mr. and Mrs. Pierpont and their attorney arrived in Crown Point after the break. He was enroute to Crown Point from his Indiana Harbor residence to meet them when the break occurred, he said.

Estill denied reports that "Wooden Gun" John's wooden gun has been found.

He also said he has not filed and does not propose to file a claim with the county council for an appropriation to pay the expenses of his now historic flight to Tucson, Ariz., to extradite Dillinger, nearly two months ago. The costs of the air trip were estimated at \$1,500.

The sheriff likewise has not filed her request for an appropriation to pay special guards about \$5,000 for the 32 days of Dillinger's stay in jail before he took French leave. She still expects to attempt to obtain pay for the guards, but doesn't know when, she said.

Appropriation requests from Estill and the sheriff were expected to be presented to the county council, which started a two-day session in Crown Point this morning.

#### Report Ready Next Week

The jailbreak probe was moving quietly today. Witnesses were to be questioned, but not until this afternoon. A report of the state's investigation will not be completed until next week. Estill said his report of the county's probe will be furnished as soon as the state's report is issued.

Whatever the U. S. justice department is doing in the case is secretive. Justice agents are reported to be seeking Dillinger for interstate auto theft and for kidnaping under the "Lindbergh" kidnaping law.

Dillinger was no more elusive than Elaine Burton, who represented herself as Mrs. Dillinger to get into the jail last week to give the gang leader a code message; and her sweetheart, John Hamilton, his henchman, and co-defendant in the East Chicago murder-holdup charge and Herbert Youngblood, accused Gary Negro murderer, who got away with Dillinger.

A Dillinger gangster, Hilton O. Crouch, was sent to the state prison for 20 years when he was sentenced today on conviction of the

story of how Dillinger made his successful break.

#### Will Not Resign

The two say they have found evidence of corruption and collusion, and a county jail apparently run by trustees, a jail administration grossly inefficient and the guarding of prisoners handled carelessly.

These investigators have been ordered by Gov. Paul V. McNutt to continue their inquiry until every clue has been run down and all evidence of any nature put into the record. It is evident that their objective is to find someone upon whom to place the responsibility.

While they continue their probe, rumors concerning the possibility of impeachment proceedings against Mrs. Holley continue to spread rapidly. Mrs. Holley says she will not resign and will fight any attempt to oust her.

#### Remember Joe Veresh

Many of these "defenders" also recalled the conditions surrounding the county jail during a former republican regime when Judge Martin Smith was on the criminal bench, and a republican was serving as sheriff.

Judge Smith was walking home to lunch one day when he was greeted:

"Good morning, judge."

Looking up, the judge blinked his bewildered eyes. It was Joe Veresh.

Instantly the judge recalled that a few weeks previously he had sentenced Mr. Veresh to the state's custody for a term of sufficient length that he still should have been behind the bars.

Investigation later disclosed that not only Mr. Veresh but also numerous other prisoners had been named trustees and that the liberties given the trustees included permission to go downtown for lunch or on any other errands they desired outside the confines of the jail.

#### Trustees Are Trusted

according to widespread reports today.

Mrs. Holley said "maybe the reports are true," but otherwise declined to comment on the rumors.

Despite the sheriff's reticence, county political observers claimed Baker would be "sacrificed" on the altar of politics in an attempt to take the ouster "heat" off of Mrs. Holley and, at the same time, put the republican warden in position to be blamed, at least inferentially, for the jailbreak, shifting part of the responsibility from the shoulders of the democratic official to her G. O. P. appointee.

**Murray, Holley Confer**

Judge William J. Murray of Lake criminal court, who was reported to be the motivating spirit in the rumored Baker ouster movement, conferred at length with the warden last night. Judge Murray conferred with Mrs. Holley and her chief deputy-nephew, Carroll Holley, this morning. What was said in the conference could not be learned, but Judge Murray had this to say at noon today:

"The warden of any jail is responsible for its security or insecurity. Mr. Baker was appointed as an experienced warden by Sheriff Holley. He had experience from his services under previous sheriffs. I don't believe Mrs. Holley is responsible for the jail's security or insecurity after she appointed the warden under those conditions."

Judge Murray added significantly that "I know what I would do if I were Mr. Baker."

**Baker Remains Silent**

The warden apparently knew what he proposes to do, but he kept it to himself when questioned today. He made no statement.

Baker has been warden of the county jail for years and apparently kept out of active politics. He served under the former republican sheriff, Ben Strong, and then under Joe Kyle of Gary, the G. O. P. predecessor of the late sheriff, Dr. Roy F. Holley, who was succeeded by his widow last year. Baker's work previously has not been criticised.

Asked today about any new ouster developments she has learned, Mrs. Holley admitted that she is reconciled to the probability that an effort would be made to force her out of office. She repeated her assertion that she will fight any such maneuver.

"I suppose they'll try to oust me," she said, without identifying "they."

"It's a bitter pill, all this hubbub," she continued. "I've tried so hard to make good."

"The trouble with my critics is that they don't seem able to realize how helpless I was in this case or how helpless the guards were."

**"It's Easy to Boast"**

"It's easy to sit around the fire-side and boast about what 'I would do if that mug tried to break jail.' Those who do this don't stop to consider what they might have done if a desperate prisoner such as Dillinger pushed a machine gun against their tummies."

"My guess is that they would do exactly as they were told to do. They would do just the same as the guards did, except that they might have put up a little more fight."

"I'm sick of the whole thing. The sooner its dropped, the better I'll like it."

The joint state and county probe into the jailbreak continued with deliberation today.

Five more state investigators were added to the force assisting Edward Barce, deputy attorney-general, and Prosecuting Attorney Robert G. Estill. Four of the in-

runaround when he carried away \$20,000 from the First National bank, after killing Policeman O'Malley."

Mrs. Holley also took a poke at Warden Louis Kunkel of the Michigan City prison during her combative mood this morning. Warden Kunkel, she said, in substance, should be seen and not heard in any remarks relative to the Lake county jailbreak in view of the 10-convict walkout at the penitentiary last fall.

**Sheriff's Car Returned**

She said she understood Kunkel has had some critical remarks to make about the Crown Point jail incident.

The sheriff's car, which Dillinger stole to use in making his escape and later abandoned in Chicago, has been returned. The car will not be placed in a museum or on display in the county fairgrounds, it was learned.

Aside from the "maybe" that Baker will be discharged or resign with an "ill health" or some other explanation, Mrs. Holley said she does not propose other changes in her county jail administration. Trusty prisoners still are being used as turnkeys, she said.

Barce criticises the use of trustees in responsible jobs, claiming his investigation shows that the jail "apparently has been run by trustees."

**Says Outlaw Had Help**

Indianapolis dispatches quote the attorney-general with the statement that "every hour we get more information that leads us to believe the Dillinger break did not just happen, but was planned."

"Dillinger had help," Lutz declared.

Lutz claimed the state has obtained sufficient information to discredit the story told by Ernest Blunk, criminal court fingerprint "expert," who was one of the hostages forced by Dillinger to accompany him on his flight; as far as Peotone, Ill. Blunk was arrested with Cahoon and charged with aiding the break. He has been released on his own recognizance at the instigation of his employer, Judge William J. Murray of criminal court.

Blunk this morning referred Sergt. Sandor Singer of the Hammond police, special investigator retained by Estill for the jailbreak probe, to his attorney, Allen P. Twyman of East Chicago, when the officer told him he was to be further questioned. Blunk told Singer he would make no additional statements on advice of his attorney.

Interested in Phone Calls

The attorney-general, as well as his deputy in Crown Point and Estill, were interested in evidence showing that only three telephone calls were made from the jail within the first hour after Dillinger escaped, one to East Chicago, one to Gary and the third to Dyer, and that the state police stationed in the Tremont barracks, only 25 miles away, were not notified.

Estill said "it is particularly interesting that no calls to the south or east were made to halt the getaway; no one is supposed to have known Dillinger was going to follow a western route."

Investigators expressed surprise

East Chicago murder money hunter and Herbert Youngblood, accused Gary Negro murderer, who got away with Dillinger.

A Dillinger gangster, Hilton O. Crouch, was sent to the state prison for 20 years when he was sentenced today on conviction of the \$21,000 Massachusetts Avenue State bank robbery in Indianapolis last summer.

**"Seen" in New Castle**

A new angle, which local investigators viewed dubiously, developed in Toledo, O., when William Bierwirth, Lucas county deputy sheriff, claimed today to have authentic information that Charles "Pretty Boy" Floyd, notorious outlaw of the southwest, was in Toledo about the same time Dillinger made his break.

Investigators could see no connection, since Dillinger escaped westward and eventually found his way to Chicago, where he is suspected of being in hiding.

Another report, also given little credence, came from New Castle, Ind., where a restaurant proprietor claimed to have served a mustached-Dillinger and Hamilton last night.

Following up Dillinger clues, Indianapolis police last night questioned and later released Mary Kinder, Pierpont's sweetheart who was arrested with the gang in Tucson; her sister, Mrs. Margaret Behrens, and an unidentified young man. The capital police believed Dillinger or an emissary was in the downstate city.

# MEX SOLDIERS EXECUTE 9 OF PEASANT PARTY

Mexico City, March 8.—Nine members of the agrarian, or peasants' party, were executed by a firing squad at Tlalixtlan, state of Vera Cruz, today. An army colonel, whose name was withheld, ordered the execution, according to meager reports received here.
